The Thomas County Board of Equalization convened in open and public session at 11:30 a.m., in the Commissioners meeting room of the Thomas County Courthouse, Thedford NE. Also present were board secretary/County Clerk Lorissa Hartman, County Treasurer Andrea Thomas, County Sheriff Gary Eng, County Attorney Kurt Arganbright and Twyla Witt.

Vice Chairman Moody reconvened the meeting at 11:57 a.m.

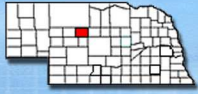
Motion made by Herbaugh and second by Moody to set the levies for the Thomas County political subdivisions as follows:
